**Yahoo Japan Corporation Determines Issue Price for Stock Options
(Subscription Rights)**

Effective January 28, 2005, based on a resolution at a meeting of the Board of Directors on January 20, 2005, the issue price and other conditions for stock options were determined as follows.

1. Issue date for stock options: January 28, 2005
2. Number of stock options to be issued: 43 units
3. Price of stock option: Issued at no cost to the receiver
4. Number and type of the Company's shares to be issued on exercise of stock options:
43 common shares
(Each stock option is equivalent to one common share)
5. Issue price for stock options: ¥523,000 per common share
6. Total value of stock options if exercised: ¥22,489,000
7. The amount of the issue price for each common share on the exercise of stock option that is not included in capital: ¥261,500
8. The number of people to be granted stock options: A total of 29 employees
9. Period to exercise the subscription rights: From June 18, 2006 to June 17, 2014
